### SUBJECT: REQUEST FOR AUTHORIZATION TO LEAVE SCHOOL UNAIDED VALID FOR ENTIRE SCHOOL YEAR

#### THEY DECLARE

- That they are aware of the organizational provisions laid down by the school and that they agree with and accept the criteria and procedures laid down by the school with regard to the actual and potential supervision of minors;
- That they are aware that, outside school hours, this responsibility falls entirely on the family;
- That they are unable to guarantee the presence of the parents or other adults at the school exit;
- That they have assessed the characteristics of the route between home and school and the potential dangers;
- That their child knows the route because they have already travelled it unaccompanied;
- That they have assessed their child's ability to act independently, their characteristics and usual behaviour;
- That they are willing to cooperate with the school in any protection and prevention initiatives and to exercise continuous supervision over the child;

#### THEY REQUEST

Pursuant to Article 19-bis of Law No. 172 of 4 December 2017, which provided for the conversion, with amendments, of Decree Law No. 148 of 16 October 2017, which the pupil may be authorized to leave school independently, without the presence of accompanying persons

#### UNDERTAKE TO

- Monitor their children's travel times and habits in order to avoid any dangers;
- Inform the school promptly if safety conditions change;
- To personally collect the child at the school's request and in the event of safety concerns;
- Constantly remind the child of the need for proper behaviour and attitudes and respect for the rules of the road;
- Inform the school promptly if conditions change.

With this request, they exempt the school staff from responsibility associated with fulfilling their duty of supervision as required by law.
